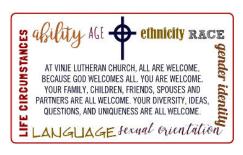

VINJE LUTHERAN CHURCH Congregational Meeting Minutes February 6, 2022, 11:00 a.m.

The Annual Meeting of Vinje was held via Zoom.

The moderator for the meeting was congregation president, Shelly Bormann.

The meeting was called to order at 11:01 a.m. A quorum of the congregation was determined to be present.

Pastor Justin Ask led the meeting in an opening prayer.

The 2021 Annual Report with the proposed budget and list of Council and nominating committee nominees was available prior to the meeting.

The agenda was presented and a motion to approve the agenda was made by Roger Kingstrom, seconded by Dan Kleven. Motion carried by voice vote.

Pastor Justin Ask provided a staff report. Youth ministry, Loving Arms and St. John's Lutheran were all included in the highlights.

Secretary's report was made by noting that the minutes of the 2021 Annual Meeting on February 7, 2021, and minutes of the special meeting on November 3, 2021, were included in the Annual Report. A motion to approve the 2-7-21 minutes was made by Carol Maursetter, seconded by Karla Tinklenberg and carried by voice vote. Motion to approve the 11-3-21 minutes was made by Char Kingstrom, seconded by Rick Loseth, and carried by voice vote.

Treasurer's report was presented by Christina Boike. The year was positive despite the pandemic. \$731,568 was total income for the year which was under budget. Total expenses were \$746,671 which was under budget. Net assets for the year increased by \$57,812. Other highlights included the following:

Dedicated/Memorial Accounts - income of \$106,345, expenses of \$111,850 with a decrease of net assets of \$5,505.

Endowment Accounts – endowment income was \$226,498; Cemetery Fund incurred \$3,263 of expenses; Endowment disbursements totaled \$43,210; college Scholarships of \$8,010 were awarded; net Endowment assets at the end of the year totaled \$1,932,299.

Loving Arms – income of \$602,278 and expenses of \$567,216 with a net increase in assets of \$124,163.

A motion to approve the treasurer's report, subject to audit, was made by Roger Kingstrom, seconded by Marv Napgezek. Motion carried by voice vote. The pastors abstained from the vote.

The following nominees for the Nominating Committee were identified: Shelly Bormann, Brad Schmidt, Lynn Gatewood, Scott Hovland and Scott Lundy. Additional nominations were requested, none received. A motion to approve the nominations and cast a unanimous ballot was made by Deb Habbena, second by Kris Gulbransen, and the motion passed by voice vote.

The following nominees for Church Council were identified: Dan Kleven, Nicole Mages, Ben Saunders, Lynn Stier and Allie Rosendahl (youth position). Additional nominations were requested, none received. A motion to approve the nominations and cast a unanimous ballot was made by Marion Nordin, second by Rick Loseth, and the motion was passed by voice vote.

The 2022 budget was presented by Christina Boike. A copy of the Budget Worksheet was included in the Annual Report. The budget includes the following highlights:

Total projected income - \$835,756 Total projected expense - \$835,756

A motion to approve the budget was made by Christina Boike, seconded by Dan Kelven. Motion carried by voice vote. The pastors abstained from the vote.

An amendment to the church bylaws was presented as follows: Current

<u>Bylaw</u>

C12.05.01. The Congregation Council may enter into contracts of up to \$5,000 for items not included in the budget or undesignated reserve funds.

Proposed Amended Bylaw

C12.05.01. The Congregation Council may enter into contracts for items not included in the budget or undesignated reserve funds as long as the cost does not exceed 5% of the annual budget for general fund contributions,

A motion to approve the Bylaw change was made by Paul Nordin, seconded by Roger Kingstrom.

Rick Maursetter made a motion to amend by adding the following proposed language at the end of the bylaw change: "exceeding more than 5% in the calendar year will require a congregational meeting." That motion was seconded by Roger Kingstrom. The motion for that amendment did not pass.

The original motion to approve the Bylaw change without the amendment was approved by majority voice vote.

A motion to adjourn the meeting was made by Marilyn Tiede, seconded by Marion Nordin. Motion carried by voice vote.

Pastor Dane Skilbred led the congregation in a closing prayer.

In the past year I've heard numerous church council members say, "change is the only thing that never changes" and "if you aren't growing, you're dying." I'm pretty sure that is their way of saying,

"THERE IS A LOT GOING ON HERE!"

Our preschool ministry continues to provide faith formation not just to Vinje members, but the entire community. Loving Arms continues to be a premier childcare center within our Vinje walls and in the last year we have seen the number of children we serve at Praise and Play in Spicer grow significantly. The challenge for 2024 will be the opening of our third center, Discovery Hill. Each of these centers provide a daily message of faith for children to take home to their families and simultaneously meets the urgent need our community has for childcare. Current estimates suggest that just under 1,000 families in our county are unable to find an open childcare spot. I'm so proud of the significant ways that Vinje has stepped up to meet this need and share the message of Jesus with the little ones around us.

The past year has also seen a significant transformation in our gathering space as you enter the building. Responding to the council's request for an update to that space, Sara Bos, Laura Negen, and other Vinje members updated an area that welcomes us into Vinje and provides a place for many conversations. While our congregation continues to treasure the sacred Saint John's prints in our hallways the new photos posted in the gathering space and fellowship hall highlight the many ways the Holy Spirit is guiding us in vibrant ministry. The cappuccino is pretty delicious too. We hope this deepens the spirit of welcome and friendship in our congregation, but that is truly up to each and every one of us — no coffee machine will match the hospitality that each of us can offer.

There are of course many other major projects that Vinje has been focused on in the last year and I'd run out of space trying to name them all. I'd also run out of space trying to name everyone who makes our ministry possible. God is doing some truly amazing and innovating things within our congregation and it wouldn't be possible without so many Vinje members who step up and respond to God's call in their lives. Including you! So thank you! Thank you for the way that you allow God to work through you to share the love of Christ with all the world!

As I look back on 2022, the best word I can use to describe how I feel about it is "grateful." I am so grateful for this congregation and its care, not only for those within our walls, but for the world around us. Though the pastors are often the public face of our church and get a lot of credit for being out front on Sundays and Wednesdays, we have a staff who does a lot of work behind the scenes all week long that often goes unnoticed. I'm sure you have noticed, as I do, that we have some pretty great things going on around here, and what our staff does is integral to all of it. We make a great team together. And this year I am especially grateful to have welcomed Pastor Erika to be a part of making this team even better.

When you're new, you get to notice things others might take for granted. It's been an interesting and exciting year to be called your pastor. Thank you for the ways you have welcomed me and my family to this place. Thank you for the ways you are teaching me about the strengths of Vinje. Thank you for the ways you are sharing your hearts of your concerns and dreams for this community as well. Thank you for the ways you have let me be "new"—putting up with silly questions or the occasions when I ask you for a re-introduction. God's Holy Spirit is truly moving in this place, it's exciting to be a part of ministry with you.

Vinje has long been known as a place which values innovation. I have found this to be quite true. As your Pastor for Worship Art, I have appreciated the creative space to curate, design and lead meaningful worship experiences for the whole congregation. What a gift. Thank you for the ways you have come along and participated in our different worship series. Thank you for the ways you have tried new things, new songs, new styles, and the ways you have appreciated old ones as well. I am grateful for my work with Karen Wojahn, she is a gift to this congregation and her faithfulness to worship is notable. I am grateful for the partnership of Pastor Dane, Pastor Justin and Pastor Andres as we work together to craft meaningful messages to speak to people's struggles and engaging your big questions of faith. Worship is a vulnerable place where we expect to meet God, and have God meet us. Thank you for entrusting this work to me, it has been a gift.

Vinje has an incredible sense of play. You have courage enough to try new experiments, knowing success or failure is not the measuring stick, but it is in the learning. My work with you also includes faith formation. We have launched a couple of faithful experiments this year, including staffed nursery time during all worship services and a special Sunday Kid's Time for preschool-grade 2 which allows for Christian Education during our Sunday services.

We continue to offer excellent programming for elementary aged students through Wednesday Live, even adding a component this year for preschool kids to join the fun. Confirmation programming remains strong and is growing each year. We have kids who are excited to come to Vinje to learn about Jesus. What a gift to steward their enthusiasm.

Vinje, you work well with others. I have enjoyed working closely with the staff of Green Lake Lutheran Ministries. We partner with these talented individuals in staffing through their Ministry Associate program, which has brought the incredible Elizabeth Faircloth this year. Vinje partners with GLLM annually in hosting a First Communion Retreat serving area churches. We partner with them for summer day camp along with our Willmar area churches, Bethel and Calvary Lutheran. GLLM offers transformational experiences onsite at Shores of St. Andrew that Vinje kids enjoy through their summer camp offerings. This summer they will also enable incredible ministry to happen for our Senior High and Middle School kids through mission and service trips. GLLM is a gift to this congregation and to the larger church.

Speaking of partnerships, I have learned so much in this year by the partnership with St. John's Lutheran Church in Raymond. I am astounded by the strength, resiliency, generosity, and joy of that place. When I talk to them about these gifts, they credit the partnership with Vinje as a source of new vitality. I am unlearning my assumptions about small churches and re-learning the gifts we share as a larger church and the many lessons we can teach each other.

Pastor Andres Albertsen, Visitation Pastor

In my fourth report of this kind to the congregation, I want to start mentioning the things I do besides visitation. Periodically, I get to preside at worship, and I am glad that the presider, according to our Vinje tradition, also has the assignment of writing and leading the prayers of intercession that come after the creed is spoken. Periodically as well, I get to preach, and in the days before the corresponding Sunday, I enjoy the little additional task of helping our communications director Sara Bos to find the appropriate illustration for the bulletin. I take turns with my colleagues to lead the Men's Bible Study on Tuesdays, and every three months or so, I get to lead the Bible Study of the Naomi/Sarah Circle of women who meet at Vinje on every first Tuesday of the month.

Every first Thursday of the month, I lead a Bible Study at Independence Place Cooperative Housing in Willmar, attended by residents who are members of Vinje, of St. John's Lutheran Church in Raymond, of other churches, and sometimes even residents who don't go to church regularly. I also take turns with my colleagues to share a reflection and a prayer with the Loving Arms kids who meet for chapel on every Monday morning, led by our director of music Karen Wojahn. I edit the History Section of the Vinje Witness, and I am so pleased when one of you will share, in your own words, a memory about a ministry you are or were part of or an event you attended, a description of an important piece of our inventory, or a reflection on why you are a Vinje member. Please let me know what story you would like to share in that section of our monthly newsletter. I participate in the weekly staff meetings, and I am thankful that we can work together in an atmosphere of respect and trust that make it possible for all of us to speak our minds and to laugh at ourselves and with one another.

During the past year, I led the funerals/celebrations of life of five of our members.

All these responsibilities don't distract me from my main ministry, which is visitation. On the contrary, they enrich my visitation ministry, while, in turn, my visitation ministry informs and inspires the other things I do. Of course, visitation is not my sole responsibility. I carry it out with my colleagues, with our ministry associate Melissa Hansen, the members of the Congregational Care Team, the members of the prayer chain, the members of Naomi/Sarah Circle who gave Christmas gifts to members in nursing homes and assisted and independent living facilities and hosted a Christmas party at Bethesda for the residents there who belong to Vinje, the kids and adults who wrote cards or made drawings to residents of the Memory Care Unit at Bethesda during the "God's Work, Our Hands" Sunday on September 11th, 2022, and the "Wednesday Live" kids who wrote Thanksgiving cards to Vinje members in nursing homes and other care facilities.

It is also worth highlighting that Congregation Care Team member Kay McLane mailed 30 "get well" cards to members we pray for on Sundays, and 38 birthday cards to members who are over 90, live in care centers, or are homebound. Kay McLane and Karen Rousseau meet once a month at church to write the bereavement cards.

The members of the Congregation Care Team had fun cooking and serving food for one of the Wednesday meals with the help of their spouses. During the first half of 2022, when food for the Loving Arms kids was still cooked in our kitchen, we continued, approximately twice a week, the ministry of delivering meals to members for whom it is difficult to cook healthy meals for themselves. Finally, I want to emphasize that visitation is also carried out by the Vinje members who pay attention to who we pray for on Sundays and take the initiative to make a call or send a card, those who make visits, provide rides, or bring meals to other members in need, and those who don't hesitate to ask other members for help.

I give thanks to God and to you for the opportunity to do ministry at Vinje, for Vinje, and with my colleagues, the other staff members, and all of you, the members of the congregation. Thank you as well for the flexibility and support that helps me fulfill my responsibilities as pastor of Iglesia Luterana Paz y Esperanza.

Having weathered the uncharted journey of Covid 19 during the past two years, in 2022 we returned to our regular worship service schedule. Wednesday evening worship services during the school year were led by Worth Saving, Nova Voices & Shalom Singers, and a new acoustic group. Holden Evening Prayer was used during the midweek Lenten services. Sunday morning worship evolved during the year from mostly traditional in the first half of the year to a more modern style the second half of the year. Worship services moved from lectionary-based to thematic in focus, with pastoral staff using a variety of media and images to underscore their messages. Live-streaming throughout the year made it possible for an increased number of people to be touched by our worship services.

In addition to the musical groups previously listed, the Vinje Choir and the JuBELLation Handbell Choir practiced regularly and provided anthems for traditional worship. A variety of soloists also shared their talents in worship, especially during the summer months. A joint worship service was held with St. Mary's parish for Thanksgiving Eve and Vinje's traditional Lessons & Carols service was held in mid-December. Three Christmas Eve services were offered, at 3:00, 5:00, and 9:00 PM. Leadership of Vinje's music ministry is a partnership shared by several members of the congregation. Thank you to Ann & Steve Trochlil, Su Michelson, Travis Michelson, Mary Hodapp, and all the participants in our many groups. Your faithfulness has enriched our worship life!

A new energy has been in the works for Vinje throughout 2022. As our Council started its tenure last year, we have been moving out of our Covid protocols. We have returned to in-person activities and worked to recapture the energy that has made Vinje so strong for so many years. I thank you as a congregation for being open to the changes. With the dedication of our talented staff, we have not only returned many of our activities but have worked to grow at Vinje and into our community. Thank you to our staff, the council and all of you for your commitment to making our community a better place.

As the Council started this past year, it was an appropriate time to work on a vision process that focused on our worship, our outreach and how we welcome each other and those interested in joining us at Vinje. Many of these steps were ambitious and still have a long way to develop. It was decided that Vinje would work towards a Modern Lutheran Worship style. One way we investigated this was with a partnership with the Calvary Partner Network (Calvary Lutheran – Alexandria). They have gone through a similar modernization and have been a valuable asset with advice and resources. This also included adding a staff person interested in engagement of our worship and music process with the new format. To date, this position has not materialized in the fashion that was hoped for. Thanks to our staff and volunteers for continuing to work on our development of Modern Lutheran Worship. Our Welcome Desk and coffee bar have been a great success in engaging members and visitors that enter our building. If you are interested, please help sign up for a shift at the Welcome Desk and share a smile and a handshake.

Loving Arms has been the subject of much transition and growth this year. As many know, Kandiyohi County is in desperate need of childcare options. In 2022, Loving Arms expanded as Praise and Play at Faith Lutheran in Spicer was acquired and expanded to include infants and toddlers. In 2023, Loving Arms will start another site on the Minn West campus as Decision Hill. We greatly appreciate the incredible work put in by the staff of VLC and LA to make this opportunity possible. Be assured that with these expansions, not only are we expanding our outreach and providing daycare possibilities but also doing so with a financially profitable model. These changes prompted VLC to approve updates to our Articles of Incorporation and creating a Limited Liability Company for Loving Arms Childcare as VLC as the sole owner.

The council has been working on other large projects that have made some headway this year. This spring we will see the installation of a columbarium outside the south entrance of the church. More information will be coming for those interested in exploring this option. An upgrade of the lighting system and fixtures in the sanctuary is also in process. With the many supply chain issues of the last few years installation was delayed, but we are anticipating the arrival and installation of the new equipment in the coming weeks. Thank you to the committees and members that have dedicated their time and talents to bringing these projects to their final stages. Our partnership with St John's Lutheran of Raymond continues to go well. The Pastors and executive committees from both congregations have met quarterly since the beginning of this partnership, making sure the needs of each of our congregations are being met. As we grow further into this partnership, we look for other ways that the gifts of each congregation can be shared. Please take in the future opportunities to worship together and enjoy fellowship with St. John's.

Moving into 2023 I am encouraged by all the great strides that Vinje has made in building a community that is bound together and nourished by our shared faith and the love, forgiveness, and purpose that comes from God. This only becomes a possibility with the incredible staff that share their gifts to bring out the talents of our many members and each of you for sharing your love and talents for each other and our community. We continue to be fiscally strong and celebrate that all we can do together.







Mission Statement: "The Childcare Centers are an integral part of the Ministry of Vinje Lutheran Church. We invite families into our faith community and care for the needs of their youngest children. Our main objective as the Premier Childcare Centers in Willmar is to provide a loving, safe and stimulating environment for children in a Christian setting."

The Ministry of our Childcare Centers continue to hold their strong reputation for quality Christian Child Care in our community. For over 25 years, we have served children from 6 weeks of age to 5 years old; with the addition of school age children in the summer months.

2022 was a busy year as we took on our second center in Spicer, MN. Praise and Play was originally just a preschool, but has since changed to be a full child care center just like Loving Arms. Children from 6 weeks of age though 5 years old are cared for at the center with the addition of school age children in the summer months.

Center number THREE, Discovery Hill, will be opening on the MinnWest Campus in spring of 2023. Much like the other two centers, Discovery Hill will care for children 6 weeks of age through 5 years old and also school age children in the summer.

COVID continues to pose challenges in the child care world. As rules and regulations are constantly changing, we are continually adapting to best suit the safety of our staff and children.

Toddlers (16 months – 33 months) 30 Preschool & Pre K (3-5 years) 58

Staffing: 19 Full-time, 9 part time, 4 on call

Fundraising: Loving Arms and Praise and Play did a wonderful job with fundraisers this year. Our families sold hundreds of pastry puffins to their friends and families. In a continued tradition, Loving Arms sold Geraniums just before Mother's Day. With 300 flowers pre-ordered, the congregation and community members bought every single one, thus making the fundraiser a huge success.

I feel honored to be part of the team at Vinje Lutheran Church, and am grateful to lead Loving Arms and Praise and Play Childcare Centers. I'm continually excited for the changes in Ministry at Vinje and am looking forward to the growth and expansion of center number THREE in 2023.

- Received, with gratitude, gifts that allow us to maintain excellent ministry, to complete facility updates, and to reach out into the community to help our neighbors

Property Committee

It has been a busy year for projects, repairs, and maintenance at Vinje. Here is a brief review of some of the projects we have been working on:

Columbarium – After many years, we have committed to the building of a columbarium on the south side of the building. This will likely be completed in 2024. Special thanks to Tim Ostby, Jan Dahl, and Cheryl Schmidt for their leadership on this project.

Sanctuary Lighting – We have contracted with Aufderworld Corporation from Plymouth to upgrade our sanctuary lighting. The previous system had become obsolete and difficult to find replacement bulbs for.

Loving Arms Classrooms – The four classrooms on the east side of the building saw a significant upgrade with new flooring, countertops, and cupboards in the last year. These were all long overdue and helped to mitigate growing safety concerns for the children who use those rooms.

Exterior Projects – A new fence was installed around the playground on the east side of the building following storm damage to the older fence. A section of sidewalk was replaced on the south side of the building.

Heating System – We were able to repair the boiler after fears that it might need to be replaced. 2023 also saw a significant expense in replacing the glycol used in our heating system following a major leak.

Thanks to everyone who has volunteered on these projects and to Joe Gatewood and Brad Michelson for their leadership on most of these efforts.

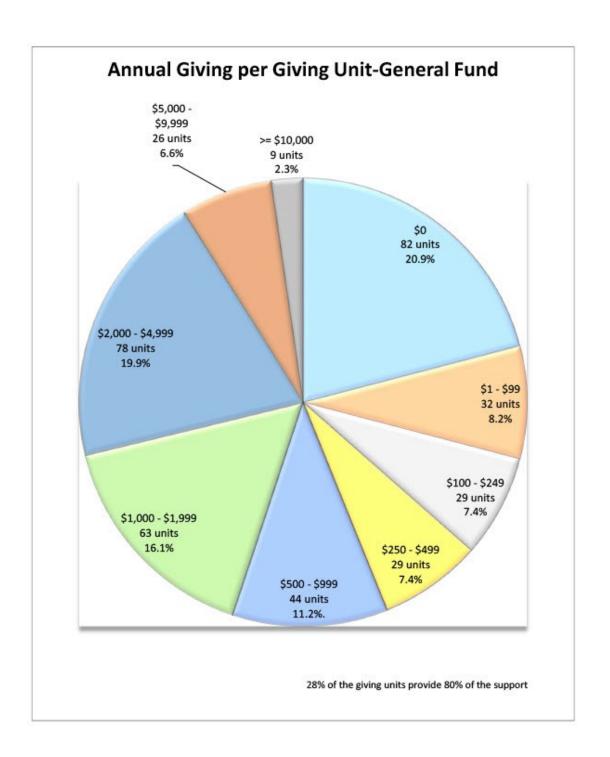
